- 9th RACE Prior to the opening of wagering It was originally announced that Race 9 would be the only race on the card to be contested on the turf course. At 21 minutes prior to the running of Race 2, management made the decision to also remove Race 9 from the turf due to weather conditions. The change was posted and announced before the start of any multi-race wagers involving Race 9. Due to several late scratches, Super Hi-5 wagering was cancelled and refunds issued when the field was reduced to six.
