TEST: 1<sup>st</sup> 3 & 11, 2<sup>nd</sup> 4 & 6, 3<sup>rd</sup> 1 & 6, 4<sup>th</sup> 1 & 6 (C 2 & 8), 5<sup>th</sup> 7 & 9 (C 4 & 8), 6<sup>th</sup> 1 & 9, 7<sup>th</sup> 4 & 11, 8<sup>th</sup> 4 & 7, 9<sup>th</sup> 5 & 12.

1<sup>st</sup> RACE Amanda K. Poston rode #1 "Where's Jack", her third probationary mount, and she was granted an Apprentice Jockey license.

2<sup>nd</sup> RACE Super Hi-5 and Superfecta wagering were not offered when the field was reduced to five prior to the opening of wagering.

3<sup>rd</sup> RACE Super Hi-5 wagering was not offered when the field was reduced to six prior to the opening of wagering.

4<sup>th</sup> RACE #10 "Twirling Troillet" (Mitchell Murrill) finished sixth and required the assistance of the KHRGC veterinarians and the horse ambulance. It was later reported that the horse had suffered a post-race heatstroke and he was placed on the See State Vet list.

5<sup>th</sup> RACE CLEAR


6<sup>th</sup> RACE #12 "River Mischief" (Rafael Bejarano) trailed the field, was eased, and required the assistance of the KHRGC veterinarians and the horse ambulance. It was later reported that the filly had returned lame and she was placed on the See State Vet list.

7<sup>th</sup> RACE CLEAR

8<sup>th</sup> RACE Super Hi-5 wagering was not offered when the field was reduced to six prior to the opening of wagering.

An objection was lodged by the rider of sixth place (last) #3 "Beach Walkn" (Luan Machado) alleging interference by the rider of second place #7 "Callie's Grit" (Axel Concepcion) in the stretch. After reviewing the race replay and interviewing the riders, the stewards determined that #3 steadied slightly while being rapidly overtaken on both sides. There was no change in the order of finish and the race was posted official.
