1st RACE Superfecta wagering was not offered when the field was reduced to five prior to the opening of wagering.

2nd RACE Voided 2 claims - submitted for scratched horse

3rd RACE The claim of #1 "Pole Setter" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

4th RACE CLEAR


5th RACE A Stewards Inquiry was posted involving the top five finishers in the stretch and, in addition, objections were lodged by the riders of both fourth place #8 "Know Who You Are" (Alex Achard) and fifth place #11 "Searcy" (Gerardo Corrales) alleging interference by the rider of second place #4 "Shakin Loose" (Keith Asmussen) approaching the 1/16 pole. After reviewing the race replay and interviewing the riders of third place #1 "Muazarah" (Francisco Arrieta), the unofficial winner #9 "The Process" (Cristian Torres), and #4, #8 and #11, the stewards determined that #4 bore out, making contact and causing a chain reaction involving #1, #8 and #11 to his outside. The stewards also determined that #9, while in front and drifting out slightly, remained clear. For the interference, #4 was disqualified from second and placed fifth, behind #11.


