1<sup>st</sup> RACE CLEAR

2<sup>nd</sup> RACE An objection was lodged by the rider of second place #3 "King's Ovation" (Joseph Talamo) alleging interference by the rider of the unofficial winner #2 "He'smyhoneybadger" (Adam Beschizza) in the stretch. After reviewing the race replay and interviewing the riders, there was insufficient evidence to warrant a disqualification and the race was posted official.

3<sup>rd</sup> RACE CLEAR

4<sup>th</sup> RACE An objection was lodged by the rider of second place #3 "Big Country" (Brian Hernandez, Jr.) alleging interference by the rider of the unofficial winner #7 "Mr. Bouma" (Corey Lanerie) in the stretch. After reviewing the race replay and interviewing the riders, there was insufficient evidence to warrant a disqualification and the race was posted official.

5<sup>th</sup> RACE The claim of #1 "Cash Refund (GB)" was voided pursuant to 810 KAR 4:050 when the horse was placed on the KHRC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

6<sup>th</sup> RACE #2 "Pennyrite" (Joseph Talamo) was pulled up approaching the 3/8 pole and required the assistance of the KHRC veterinarians and the horse ambulance. It was determined that the horse had pulled up lame and he was placed on the KHRC Vet's list.

7<sup>th</sup> RACE CLEAR

8<sup>th</sup> RACE #9 "Apart of My Charm" (Chris Landeros) was pulled up near the 3/8 pole and required the assistance of the KHRC veterinarians and the horse ambulance. It was determined that the horse had pulled up lame and she was placed on the KHRC Vet's list.
