1<sup>st</sup> RACE CLEAR

2<sup>nd</sup> RACE The claim of #4 "Charley Rude" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

3<sup>rd</sup> RACE An objection was lodged by the rider of third place #6 "Charge Account" (Cristian Torres) alleging interference by the rider of the unofficial winner shortly after the start. After reviewing the race replay and interviewing the riders, the stewards determined that there was insufficient evidence to warrant a disqualification and the race was posted official.

4<sup>th</sup> RACE CLEAR

5<sup>th</sup> RACE #6 "Candi Girl" (Gerardo Corrales) unseated her rider in the post parade, but the rider held onto the filly. The rider remounted and the race was without incident.

6<sup>th</sup> RACE #5 "Dutch Mills" (Rafael Bejarano) was a late scratch from the post parade on the advice of the KHRC veterinarian.


