TEST: 1<sup>st</sup> 1 & 9, 2<sup>nd</sup> 3 & 5, 3<sup>rd</sup> 7 & 8, 4<sup>th</sup> 7 & 9, 5<sup>th</sup> 2 & 12, 6<sup>th</sup> 3 & 6, 7<sup>th</sup> 2, 3 & 5, 8<sup>th</sup> 2, 7 & 8, 9<sup>th</sup> 5, 6 & 9, 10<sup>th</sup> 4 & 7.

1<sup>st</sup> RACE Super Hi-5 wagering was not offered when the field was reduced to six prior to the opening of wagering.

2<sup>nd</sup> RACE #7 "Sister Charlie" (Edgar Morales) finished sixth, BLED, and was placed on the See State Vet list.

3<sup>rd</sup> RACE Super Hi-5 and Superfecta wagering were not offered when the field was reduced to five prior to the opening of wagering.

4<sup>th</sup> RACE #6 "Tiger's Legacy" (Gerardo Corrales) popped the front doors of the gate open prior to the start, but was held in place by the assistant starter. The doors were closed and the start was without incident.

5<sup>th</sup> RACE Race 5 was taken off the turf. The change was posted and announced prior to the opening of wagering.

6<sup>th</sup> RACE CLEAR

7<sup>th</sup> RACE #8 "Ova Charged" (Corey Lanerie) fell and unseated her rider leaving the 1/16 pole. The rider of #1 "Current Climate" (Alex Achard) was unseated when his mount ducked to avoid the fallen horse. It was determined by the KHRGC veterinarians that Ova Charged had suffered a catastrophic injury to her right foreleg and she was humanely euthanized on the turf course. Neither rider was injured.

8<sup>th</sup> RACE #2 "Abrumar" (Gerardo Corrales) unseated his rider in the post parade, but did not get loose. The rider remounted and the race was without incident.

9<sup>th</sup> RACE CLEAR

10<sup>th</sup> RACE An objection was lodged by the rider of third place #2 "Bourbon Society" (Jareth Loveberry) alleging interference by the rider of the unofficial winner, #4 "Kinetic" (Axel Concepcion) near the 1/4 pole. After reviewing the race replay and interviewing the riders, the stewards determined that there was insufficient evidence of interference to warrant a disqualification and the race was posted official.
