Voided claim - insufficient funds

6<sup>th</sup> RACE An objection was lodged by the rider of #3 "Lucky's Strike" (Rene Diaz) who was pulled up near the 3/8 pole, alleging interference by the rider of fourth place #2 "Inspeightoftrainer" (Jose E. Lopez) near the 1/2 mile pole. After reviewing the race replay and interviewing the riders, the stewards determined that there was insufficient evidence of interference to warrant a disqualification. In addition, #3 stumbled several strides after the alleged interference, was pulled up and attended to by the KHRC veterinarians who later reported that the horse did not appear to have suffered an injury. There was no change in the order of finish and the race was posted official.
