

**INCIDENTS/INQUIRIES/OBJECTIONS**

- **Race 4** → The Judges had a general inquiry to confirm #2 Caviart War Room did conform to the breaking rule while off stride at the start. The Judges all agreed that there was no violation and allowed the race to go official.
- **Race 8** → #5 Wukong was 6<sup>th</sup> placed 9<sup>th</sup> for violation of the breaking rule by not continually losing ground while off stride and no attempt to get back on stride before the wire.
- **Race 10** → There were two placings that had to occur during this race. First, #4 Requiem did make a break in the stretch and in the opinion of the Judges did not lose sufficient ground while off stride and was 3<sup>rd</sup> placed 5<sup>th</sup> due to the violation. Also, at the start #2 Express Train did cause interference to #1 Exactly just after the start causing an interference break requiring #2 Express train to ultimately end up 4<sup>th</sup> placed 3<sup>rd</sup> placed 8<sup>th</sup> behind #1 Exactly and all others placed accordingly. The Board of Judges showed the replays from the judge's view and explained all placings on simulcast.
