1st RACE CLEAR

2nd RACE #6 "Stonevicious" (Edgar Morales) was pulled up near the 1/4 pole and required the assistance of the KHRC veterinarians and the horse ambulance. The horse was later released to the care of the private veterinarian and a claim that had been submitted for the horse was voided.

The claim of #2 "Cool Rags" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.
