1<sup>st</sup> RACE CLEAR

2<sup>nd</sup> RACE #7 "Culprit" (Francisco Arrieta) broke through the gate and unseated his rider. The horse ran loose, evading the outriders, and was scratched by the stewards. The scratch reduced the field to six, necessitating the cancellation of the Super Hi-5. The mutuels department made the proper refunds.

3<sup>rd</sup> RACE CLEAR

4<sup>th</sup> RACE #1 "Nursekringledances" (Victor R. Carrasco) was a late scratch from the post parade on the advice of the KHRG veterinarian. The scratch reduced the field to six, necessitating the cancellation of the Super Hi-5. The mutuels department made the proper refunds.

5<sup>th</sup> RACE #7 "Kilo Juliet" (Florent Geroux) was a late scratch from the post parade on the advice of the KHRG veterinarian.

#6 "Upside Out" (Francisco Arrieta) stumbled badly at the start, causing Arrieta to lose his irons. Arrieta recovered quickly, but the filly trailed the field and finished last.

6<sup>th</sup> RACE Super Hi-5 wagering was not offered when the field was reduced to six prior to the opening of wagering.

8<sup>th</sup> RACE CLEAR

9<sup>th</sup> RACE #7 "Mr. Vaggio" (Fernando De La Cruz) was fractious in the starting gate, backed out and examined and approved by the KHRG veterinarian. The horse was reloaded and the start was without incident.
