RACE A Stewards Inquiry was posted when #5 Benelux" (Adam Beschizza) unseated his rider at the start. After reviewing the race replay the stewards determined that the horse stumbled, and that no other horse was involved. There was no action taken and the race was posted official. Both horse and rider escaped injury.

The claim of #2 "Strike Appeal" was voided pursuant to 810 KAR 4:050 when the horse was placed on the KHRC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

RACE CLEAR

3rd RACE #5 "Totally Jimbo" (Gabriel Saez) got loose in the paddock, ran through the gate into the grandstand and evaded capture for quite some time. The horse was finally caught and returned to the paddock where he was a late scratch on the advice of the KHRC veterinarian. The late scratch reduced the field to five, necessitating the cancellation of the Superfecta. The mutuel department made the proper refunds.

#1 "On K P" (Rafael Bejarano) BOLTED, was eased, and was placed on the STEWARDS list.

RACE #7 "Endowment" (Javier Padron-Barcenas) finished ninth (last) and required the assistance of the KHRC veterinarians and the horse ambulance. The filly had suffered a catastrophic injury to her left knee and she was humanely euthanized.

RACE Superfeta wagering was not offered when the field was reduced to five prior to the opening of wagering.

8<sup>th</sup> RACE A Stewards Inquiry was posted when #8 "Baroness VonTrappe" (Javier Padron-Barcenas) unseated her rider approaching the 1/16 pole. After reviewing the race replay the stewards determined that the rider of #8 lacked room and while trying to check, clipped the heel of #7 to the outside. There was no action taken and the race was posted official. The horse escaped injury. Pardon-Barcenas was transported to the hospital and is reported to have only suffered minor injuries.
