1st RACE The claim of #7 "Comes a Time" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRG Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

2nd RACE CLEAR

3rd RACE The claim of #2 "Big City" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRG Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

4th RACE #1 "Fortunistic" (Summer Pauly) was injured in the starting gate and was a late scratch on the advice of the KHRG veterinarian.

5th RACE CLEAR

6th RACE #4 "Storm Cloud Rising" arrived past the Lasix administration deadline and was permitted to race without the medication. The change was posted and announced prior to the opening of wagering.

7th RACE There was a delay in loading the field when the photo finish camera operator reported an issue with both the photo finish camera and the backup camera. During the delay the horses circled behind the starting gate. Once the issue was resolved, the horses were loaded and the start was without incident. After the race, the placing judges were provided the results of the photo finish.

8th RACE The placing judges unanimously determined the order of finish without the aid of a photo due to another malfunction of the photo finish camera and the backup camera.

9th RACE The photo finish cameras functioned normally.
