4<sup>th</sup> RACE #5 "Libertyrun" (Miguel Mena) fell leaving the 1/16 pole, unseated his rider, and required the assistance of the KHRC veterinarians and the horse ambulance. After diagnostics were performed by the private veterinarian and it was determined that the horse had suffered a catastrophic injury to his left foreleg, the horse was humanely euthanized. The rider was not injured.

6<sup>th</sup> RACE An objection was lodged by the rider of fourth place #8 "Xtrema" (James Graham) alleging interference by the rider of the winner #4 "Crazy Beautiful" (Rafael Bejarano) near the 3/16 pole. After reviewing the race replay and interviewing the riders, the stewards determined that the contact between the two horses was mutual and did not warrant a disqualification. There was no change in the order of finish and the race was posted official.
