Voided claim - improperly completed

#5 "Good News Rocket" (Keith J. Asmussen) was a late scratch from the post parade on the advice of the KHRG veterinarian.

2nd RACE #1 "Hap Hot" (Luan Machado) was a late scratch from the post parade on the advice of the KHRG veterinarian. The scratch reduced the field to six, necessitating the cancellation of the Super Hi-5. The mutuels department made the proper refunds.

3rd RACE CLEAR

4th RACE #1 "Dynamite" (Joseph C. Bealnear) finished sixth, suffered a post-race heatstroke and required the assistance of the KHRG veterinarians and the horse ambulance. The filly, who required treatment by the KHRG veterinarians, was placed on the See State Vet list. Having been chosen as the post-race special, a blood sample was taken and she was excused from the test barn. Four claims that had been submitted for the filly were voided.

5th RACE CLEAR

6th RACE Super Hi-5 wagering was mistakenly listed in the official program as a option, but wagers were not accepted as the race was carded with six horses.

In additon, Superfecta, Trifecta and Show wagering were not offered when the field was reduced to four horses prior to the opening of wagering.

7th RACE CLEAR

8th RACE #3 "Papa Yo" (Cristian A. Torres) unseated his rider in the post parade and ran loose. After being caught by the outriders, the horse was examined and approved by the KHRG veterinarians and remounted. The eventual race was without incident.

9th RACE #9 "Sweet Kaufy" (Luan Machado), the winner, suffered a post-race heatstroke and required the assistance of the KHRG veterinarians and the horse ambulance. The filly, who required treatment by the KHRG veterinarians, was placed on the See State Vet list. A blood sample was taken and she was excused from the test barn.
