5th RACE #11 "Gray's Fable" was injured in the paddock and was a late scratch on the advice of the KHRGC veterinarian.

An objection was lodged by the rider of sixth place #8 "Franz Josef" (Axel Concepcion) alleging interference by the riders of both third place #9 "Ducale" (Rafael Bejarano) and the unofficial winner #3 "Scoobie Quando" (Luan Machado) in the stretch. After reviewing the race replay and interviewing the riders, the stewards determined that there was insufficient evidence of interference to warrant a disqualification and the race was posted official.

RACE Program correction - #8 "Milven" was mistakenly listed in the program to race without Lasix. The error was caught in a timely manner and the horse was permitted to race with the medication. The correction was posted and announced prior to the opening wager.

#10 "Yammy Yammy Bella" (Javier Padron-Barcenas) finished tenth and suffered post-race physical distress. The horse was placed on the See Vet list.

10th RACE A Stewards Inquiry was posted involving the top two finishers in the stretch and, in addition, an objection was lodged by the rider of second place #9 "Chasing Liberty" (Florent Geroux) alleging interference by the rider of the unofficial winner, #5 "Under Who's Radar" (Jose Ortiz) inside the 1/8 pole. After reviewing the race replay and interviewing the riders, the stewards determined that #5 ducked out as #9 was gaining to be on even terms, causing the horse to steady, change leads, lose momentum for a few strides, then gain on the leader again. For the interference #5 was disqualified and placed second behind #9. Official order of finish: 9-5-1-7
