Ortiz) at the start. After reviewing the race replay and interviewing the riders, the stewards determined that while #7 broke out slightly, #8 broke a bit behind the others, causing her own trouble. There was no change in the order of finish and the race was posted official

9th RACE A Stewards Inquiry was posted involving the top two finishers in stretch and, in addition, an objection was lodged by the rider of second place #5 "Necessity" (Irad Ortiz, Jr.) alleging interference by the rider of the unofficial winner #7 "Yes It Tiz" (Florent Geroux) in the stretch. After reviewing the race replay and interviewing the riders, the stewards determined that the slight contact that occurred several times was mutual and did not warrant a disqualification.
