1<sup>st</sup> RACE Superfecta wagering was not offered when the field was reduced to five prior to the opening of wagering.

2<sup>nd</sup> RACE Voided claim - owner not licensed

3<sup>rd</sup> RACE CLEAR

4<sup>th</sup> RACE Voided claim - owner name misspelled  
Voided claim - insufficient funds

5<sup>th</sup> RACE There was a Stewards Inquiry posted involving 2 separate incidents. #6 "Take Charge J J" (Reylu Gutierrez) unseated his rider near the 1/4 pole. After reviewing the race replay, the stewards determined that #6 ducked slightly and unseated his rider near the 1/4 pole. No other horse appeared to be involved so there was action taken regarding #6.

There was a separate Stewards Inquiry into the top 2 finishers from the 1/8 pole to the finish. In addition, an objection was lodged by the rider of second place #9 "Shogun Be Fast" (Tyler Gaffalione) alleging interference by the rider of the unofficial winner #5 "Orange Diablo" (Florent Geroux) through the stretch. After reviewing the race replay and interviewing the riders, the stewards determined that #5 drifted in several times, making contact with #9 and causing his rider to steady sharply and lose all chance. For the interference, #5 was disqualified and placed second behind #9. Official order of finish: 9-5-8-4-2

6<sup>th</sup> RACE CLEAR

7<sup>th</sup> RACE #6 "Max's Map" (Florent Geroux) unseated his rider in the post parade but did not get loose. The horse was remounted and the race was without incident.
