2nd RACE Superfecta wagering was not offered when the field was reduced to five prior to the opening of wagering.

3rd RACE CLEAR

4th RACE Super Hi-5 and Superfecta wagering were not offered when the field was reduced to five prior to the opening of wagering.

5th RACE A Stewards Inquiry was posted when #2 "Maverick Queen" (Jaime A. Torres) unseated her rider near the 5/16 pole. After reviewing the race replay, the stewards determined that the horse had ducked out slightly and unseated Torres. The horse ran with the field and was caught without incident. Torres was not seriously injured.

6th RACE Super Hi-5 wagering was not offered when the field was reduced to six prior to the opening of wagering.

#5 "Moon Mystique" (Alex Achard) was injured in the starting gate and was a late scratch on the advice of the KHRG veterinarian. The scratch further reduced the field to five, necessitating the cancellation of the Superfecta. The mutuels department made the proper refunds.

7th RACE Superfecta wagering was not offered when the field was reduced to five prior to the opening of wagering.

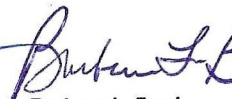
8th RACE Super Hi-5 and Superfecta wagering were not offered when the field was reduced to five prior to the opening of wagering.
