3rd RACE A Stewards Inquiry was posted involving an incident leaving the 6-1/2 pole when the rider of #3 "Babe in the Woods" (Brian Hernandez, Jr.) was unseated. After reviewing the race replay and interviewing the riders of the unofficial winner #1 "Candy Landy" (Martin Garcia"), second place #5 "West Omaha" (Florent Geroux), third place #2 "Floored" (Rafael Bejarano) and sixth place #4 "Austin Traffic" (Jane Elliott), the stewards determined that the horses mentioned were racing in tight quarters shortly after the start, and that #1 drifted out slightly and caused #3 to clip heels and unseat her rider. The loose horse, who reportedly suffered lacerations when she attempted to jump the rail near the 5/16 pole, ultimately ran into the 1/4 chute and was caught there. She was evaluated by the KHRC veterinarians and transported to her barn in the horse ambulance. The rider was not injured.
