Race" (Tyler Gaffalione) alleging interference by the rider of third place #4 "Friar Laurence" (Carlos Barbosa) approaching the 3/8 pole. After reviewing the race replay and interviewing the riders, the stewards determined that #4 ducked out and made contact with #2, causing him to steady and lose momentum. For the interference, #4 was disqualified from third and placed fourth, behind #2. Official order of finish: 5-8-2-4-3
- RACE Super Hi-5 wagering was not offered when the field was reduced to six prior to the opening of wagering.
- 5th RACE #10 "Scotch Chocolate" (Corey Lanerie) finished ninth and required the assistance of the KHRGC veterinarians and the horse ambulance. It was lter reported that the horse had returned lame, and he was placed on the See State Vet list.
- 6th RACE An objection was lodged by the rider of second place #6 "Justifreak" (Luis Saez) alleging interference by the rider of the unofficial winner, #8 "Texas Town" (Rafael Bejarano) at the start. After reviewing the race replay and interviewing the riders, the stewards determined that #8 broke in slightly at the start, but appeared to be clear of #6. There was no change in the order of finish and the race was posted official.
