3rd RACE #11 "Sgt. Garcia" (Brian J. Hernandez, Jr.) suffered an injury near the 5/16 pole and unseated his rider. The KHRG veterinarians determined that the horse had suffered a catastrophic injury to his left foreleg and he was humanely euthanized on the racetrack. Hernandez was injured in the incident and was transported to the hospital. Four claims that had been submitted for the horse were voided.

5th RACE The claim of #6 "King Peanut" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRG Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

8th RACE Super Hi-5 and Superfecta wagering were not offered when the field was reduced to five prior to the opening of wagering.

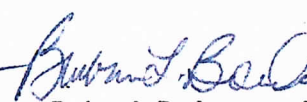
9th RACE A Stewards Inquiry was posted involving the top two finishers and, in addition, an objection was lodged by the rider of second place #9 "Miracle Worker" (Tyler Gaffalione) alleging interference by the unofficial winner, #7 "Gardiner" (Jose L. Ortiz) in the stretch. After reviewing the race replay and interviewing the riders, the stewards determined that the slight contact that occurred inside the 1/16 pole did not affect the order of finish and the race was posted official.
