The KHRG veterinarians determined that the horse had suffered a catastrophic injury to his left foreleg and he was humanely euthanized on the racetrack. Hernandez was injured in the incident and was transported to the hospital. Four claime that had been submitted for the horse were voided.

RACE A Stewards Inquiry was posted involving the top two finishers and, in addition, an objection was lodged by the rider of second place #9 "Miracle Worker" (Tyler Gaffalione) alleging interference by the unofficial winner, #7 "Gardiner" (Jose L. Ortiz) in the stretch. After reviewing the race replay and interviewing the riders, the stewards determined that the slight contact that occurred inside the 1/16 pole did not affect the order of finish and the race was posted offical.
