1st RACE CLEAR

2nd RACE Superfecta wagering was not offered when the field was reduced to five prior to the opening of wagering.

Voided claim - horse name misspelled
Voided claim - insufficient funds

3rd RACE CLEAR

4th RACE A Stewards Inquiry was posted when #1 "Chipmunk" (Adam Beschizza) ducked in shortly after the start, bumped the temporary rail and unseated her rider. The horse ran with the field and was caught without incident. The rider was not injured. After reviewing the race replay the stewards determined that no other horse had been involved. No action was taken and the race was posted official.

5th RACE CLEAR

6th RACE Voided claim - incorrect claiming price


An objection was lodged by the rider of second place #1 "Caramelito" (Rene Diaz) alleging interference by the rider of the unofficial winner #6 "Shadow Matter" (Tyler Gaffalione) in the stretch. After reviewing the race replay and interviewing the riders, the stewards determined that the slight contact that occurred approaching the finish did not warrant a disqualification and the race was posted official.

7th RACE CLEAR

8th RACE #8 "Cancel This" (Martin Garcia) ran off in the post parade with the rider aboard. The horse was eventually pulled up near the 1/4 pole with the assistance of the outrider. The horse was examined and approved by the KHRC veterinarian, started, and the race was without incident.
