1<sup>st</sup> RACE An objection was lodged by the rider of tenth place #10 "Weighted Average" (Cristian Torres) alleging interference by the rider of fifth place #12 "She is Invincible (GB)" (Jaime Torres) near the 1/4 pole. After reviewing the race replay and interviewing the riders, the stewards determined that there was insufficient evidence to warrant a disqualification and the race was posted official.

2<sup>nd</sup> RACE #1 "Quimichis" (Gerardo Corrales) was injured in the starting gate and was a late scratch on the advice of the KHRC veterinarian.

3<sup>rd</sup> RACE Super Hi-5 wagering was not offered when the field was reduced to six prior to the opening of wagering.

4<sup>th</sup> RACE CLEAR

5<sup>th</sup> RACE Super Hi-5 wagering was not offered when the field was reduced to six prior to the opening of wagering.

6<sup>th</sup> RACE #1 "Native Thunder" (Reylu Gutierrez) was eased and required the assistance of the KHRC veterinarians and the horse ambulance. It was later reported that the horse had returned lame and was placed on the See State Vet list.
