6th RACE A Stewards Inquiry was posted involving fifth place #2"Jinxzi" (Junior Alvarado) and sixth place #5 "Open Court" (Ben Curtis) near the 5/8 pole. After reviewing the race replay and interviewing the riders, the stewards determined that #5 was attempting to go inside of #2 but lacked sufficient room and checked sharply when the horse reacted to being in tight. There was no action taken and the race was psoted official.

After the claimed horses left the test barn it was discovered that there had been insufficient funds on deposit with the Horseman's Bookkeeper in the account of Felipe Salas for the claim of #10 "Colonel Compton". The stewards immediately voided the claim and contacted Salas and trainer Philip A. Bauer who the horse had been claimed from and arranged for both parties to meet at the test barn and transfer the horse back to Bauer. The transfer took place without incident.

7th RACE #7 "Warrior Johnny" (Irad Ortiz, Jr.) was a late scratch from the post parade on the advice of the KHRG veterinarian. The scratch reduced the field to six, necessitating the cancellation of the Super Hi-5. The mutuels department made the proper refunds.

8th RACE Super Hi-5 wagering was not offered when the field was reduced to six prior to the opening of wagering.

#2 "Party Pauline" (Irving Moncada) suffered a post-race heatstroke and required treatment by the KHRG veterinarians. The filly was placed on the See State Vet list.
