1st RACE Superfecta wagering was not offered when the field was reduced to five prior to the opening of wagering.

#2 "Magic Shot" (Mitchell Murrill) was a late scratch from the post parade on the advice of the KHRC veterinarian. The scratch reduced the field to four, necessitating the cancellation of the Superfecta. Management also elected to cancel Show wagering. The mutuels department made the proper refunds.

After reviewing the race replay and interviewing the riders, the stewards determined that #5 bore in, making contact and impeding #6 by causing him to steady and lose momentum. For the interference #5 was disqualified from first and placed second behind #6.
