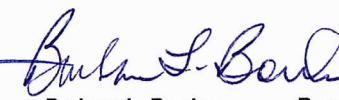

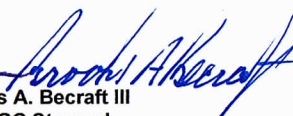
An additional scratch due to track condition was
