TEST: 1<sup>st</sup> 2 & 4-clm voided (C 1, 3 & 5), 2<sup>nd</sup> 1 & 10 (C 13), 3<sup>rd</sup> 3 & 4, 4<sup>th</sup> 6 & 7, 5<sup>th</sup> 4 & 7, 6<sup>th</sup> 10 & 11, 7<sup>th</sup> 3 & 6, 8<sup>th</sup> 2 & 8 (C 7), 9<sup>th</sup> 10 & 11.

1<sup>st</sup> RACE Super Hi-5 wagering was not offered when the field was reduced to six prior to the opening of wagering.

The claim of #4 "Run Smitty Run" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

2<sup>nd</sup> RACE Voided claim - submitted for scratched horse

3<sup>rd</sup> RACE Super Hi-5 wagering was not offered when the field was reduced to six prior to the opening of wagering.

4<sup>th</sup> RACE Voided claim - track misspelled

5<sup>th</sup> RACE CLEAR

6<sup>th</sup> RACE CLEAR

7<sup>th</sup> RACE Superfecta, Trifecta and Show wagering were not offered when the field was reduced to four prior to the opening of wagering.


#1 "Order of Magnitude" (Cristian Torres) was a late scratch from the post parade on the advice of the KHRC veterinarian. The scratch reduced the field to three and necessitated the cancellation of the Exacta. Management also opted to cancel Place wagering due to the late scratch. The mutuels department made the proper refunds.


#3 "Watasha" (Gerardo Corrales) finished third (last), BLED, and was placed on the See State Vet list.

8<sup>th</sup> RACE Super Hi-5 and Superfecta wagering were cancelled when the field was reduced to five shortly after wagering began. The mutuels department made the proper refunds.
