A Stewards Inquiry was posted when #4 "Out Work'n" (Rene Diaz) unseated his rider near the 5/8 pole. After a thorough review of the race replay the stewards determined that the horse was placed just behind horses and remained there for several strides before clipping the heel of a rival in front of him, taking an awkward step, and unseating Diaz. There was no action taken and the race was posted official. Diaz was transported to the hospital. The horse was later examined and placed on the See State Vet list.
