3rd RACE #1 Wake Surf" was injured in the paddock and was a late scratch on the advice of the KHRGC veterinarian. The scratch reduced the field to six, necessitating the cancellation of the Super Hi-5. The mutuels department made the proper refunds.

4th RACE An objection was lodged by the rider of second place #3 "Lil Muggs" (Mitchell Murrill) alleging interference by the unofficial winner, #11 "Terrapin Station" in the stretch. After reviewing the race replay and interviewing the riders, the stewards determined that the rider of #3 checked and changed course when he lacked room while attempting to overtake #2 "D Bigelow" (Martin Chuan) who was in front, and that #11 maintained a straight course throughout the stretch. There was no change in the order of finish and the race was posted official.
