#1 "Sant' Antimo" (Gabriel Saez) was pulled up in the stretch and left the track on his own power. It was later reported by the KHRG veterinarian that the horse had returned lame and he was placed on the See State Vet list.

6th RACE

#5 "Mubarez" (Axel Concepcion) suffered a post-race heatstroke and required the assistance of the KHRG veterinarians. The horse was placed on the See State Vet list.

The claim of #8 "Campaign Trail" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRG Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

7th RACE

A Stewards Inquiry was posted involving third place #8 "Grazie Prego" (Florent Geroux) and the unofficial winner #7 "Tizmatic" (Axel Concepcion) in the stretch. After reviewing the race replay and interviewing the riders, the stewards determined that #7 angled out through the stretch, carrying #8 out and making contact several times. For the interference #7 was disqualified from first and placed third behind #8. Official order of finish: 6-8-7-3-11

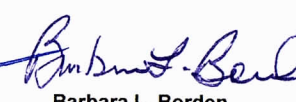
