

7th RACE An objection was lodged by the rider of fifth place #5 "Corner Kick" (Cristian Torres) alleging interference by the rider of the unofficial winner #2 "Promises to Dance" (Tyler Gaffalione) near the 1/4 pole. After reviewing the race replay and interviewing the riders, the stewards determined that there was insufficient evidence to warrant a disqualification and the race was posted official.
