TEST: 1st 3 & 7 (C 4), 2nd 4 & 7, 3rd 4 & 5 (C 6), 4th 1 & 2, 5th 1, 1a & 7, 6th 1 & 10, 7th 10 & 11, 8th 1, 2, 3 & 7, 9th 1a, 2 & 5, 10th 6, 8, 9 & 11, 11th 6 & 7.

1st RACE An objection was lodged by the the trainer (Donald Habeeb) of third place #1 "C Islandsurprise" (Miguel Mena) alleging interference by the rider of second place #5 "I Dream of Lois" (Corey Lanerie) near the 1/4 pole. Upon returning to be unsaddled the rider of #1 (Mena) lodged the same objection from the scale. After reviewing the race replay and interviewing the riders, the stewards determined that #1 was getting out from the rail while being passed by #5. There was no change in the order of finish and the race was posted official.

2nd RACE CLEAR

3rd RACE Voided claim - no race number on envelope

4th RACE The claim of #2 "Runnin' Ray" was voided pursuant to 810 KAR 4:050 when the horse was placed on the KHRC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

5th RACE Superfecta, Trifecta, Place and Show wagering were not offered when the field was reduced to three betting interests prior to the opening of wagering.

Prior to the opening of wagering, the mutuels manager made the request to offer Exacta wagering on the three betting interest field. Permission was granted pursuant to 810 KAR 6:020 Section 3, subsection (3).

6th RACE Voided claim - wrong race number

7th RACE CLEAR

8th RACE Superfecta, Trifecta, Place and Show wagering were not offered when the field was reduced to four prior to the opening of wagering.

9th RACE #10 "Line Judge" (Joseph Rocco, Jr.) finished tenth and required the assistance of the KHRC veterinarians and the horse ambulance. The horse was reported to be lame and was released to the care of the private veterinarian.

10th RACE CLEAR

11th RACE Super Hi-5 wagering was not offered when the field was reduced to six prior to the opening of wagering.
