1<sup>st</sup> RACE #7 "Norma Jean B." (Mitchell Murrill) finished eighth and BLED

3<sup>rd</sup> RACE A Stewards Inquiry was posted regarding an incident shortly after the start. In addition, the rider of second place #1 "High Regard" (Rafael Bejarano) lodged an objection alleging interference by the rider of the unofficial winner #2 "Jeweled Princess" (Brian Hernandez, Jr.) soon after the start. After reviewing the race replay and interviewing the riders, the stewards determined that #2 came down into the path of #1 causing her to clip heels, stumble and lose momentum. For the interference, #2 was disqualified from first and placed second behind #1. Official order of finish: 1-2-3-4

6<sup>th</sup> RACE #2 "Mojo Man" (Tyler Gaffallone) was a late scratch from the post parade on the advice of the KHRC veterinarian. The late scratch reduced the field to five which necessitated the cancellation of the Superfecta. The mutuels department made the proper refunds.

An objection was lodged by the rider of second place #5 "Honest Mischief" (Javier Castellano) alleging interference by the rider of the unofficial winner #7 "Lasting Legacy" (Paco Lopez) in the stretch. After reviewing the race replay and interviewing the riders, the stewards determined that #7 carried #5 out while drifting and made contact late. For the interference, #7 was disqualified from first and placed second behind #5. Official order of finish: 5-7-8-6

7<sup>th</sup> RACE #4 "More Good Times" (Ricardo Santana, Jr.) finished sixth and required the assistance of the KHRC veterinarians and the horse ambulance. The horse was transported to the Churchill Downs Equine Medical Center for evaluation. Veterinary report is pending.
