3rd RACE #9 "Moonchild" (Florent Geroux) was a late scratch from the post parade on the advice of the KHRC veterinarian.

4th RACE #4 "Ernie Banks" (Miguel Mena) was a late scratch from the post parade on the advice of the KHRC veterinarian.

5th RACE A Stewards Inquiry was posted involving the start of the race. It was immediately apparent that the start took place prior to both #6 "Mechanicville (Julien Leparoux) and #12 "Catman" (Tyler Gaffalione) being loaded in the gate. After a thorough review of the race replay and interview with the starter, the stewards also determined that due to a malfunction of the gate, no rider, assistant starter or horse was prepared for the start. The stewards determined that all horses in the field were precluded from obtaining a fair start, declared the race a NO CONTEST and ordered all money wagered on the race to be refunded.

10th RACE #6 "King Gypsy" (Gerardo Corrales) broke through the gate prior to the start, the rider stayed aboard and the assistant starter gamely held on to the horse as he was pulled to the ground. The horse was approved by the KHRC veterinarian, reloaded, and the start was without incident.

#10 "Snake Doctor" (Ricardo Santana, Jr.) fell and unseated his rider leaving the 1/2 mile pole. The horse was attended to by the KHRC veterinarians who determined that he had suffered a catastrophic injury to his right foreleg. The horse was humanely euthanized on the course.
