1<sup>st</sup> RACE CLEAR

2<sup>nd</sup> RACE A Stewards Inquiry was posted involving several horses in the stretch and, in addition, an objection was lodged by the rider of third place #9 "Three On the Tree" (Julien Leparoux) alleging interference by the rider of second place #2 "Thethrillofvictory" (Irad Ortiz, Jr.) at the top of the stretch. After reviewing the race replay and interviewing the riders, including the unofficial winner #1 "Ironsides" (Rafael Bejarano), the stewards determined that #9 lacked room while between horses and was checked as he was being passed by both #1 and #2. There was no change in the order of finish and the race was posted official.

Dead Heat for SHOW

3<sup>rd</sup> RACE Supergecta and Trifecta wagering were not offered when the field was reduced to four prio to the opening of wagering.

4<sup>th</sup> RACE CLEAR

5<sup>th</sup> RACE CLEAR

6<sup>th</sup> RACE Superfecta wagering was not offered when the field was reduced to five prior to the opening of wagering.


An objection was lodged by the rider of third place #8 "Souper Munnings" (Declan Cannon) alleging interference by the rider of the unofficial winner #4 "Oeuvre" (Jareth Loveberry) near the 1/8 pole. After reviewing the race replay and interviewing the riders, the stewards determined that #4 drifted out to the #8 who was racing wide, then continued to drift after passing and being clear of #8. There was no change in the order of finish and the race was posted official.


7<sup>th</sup> RACE #3 "Blame the Stars" (Gerardo Corrales) was pulled up near the 1/2 mile pole and required the assistance of the KHRC veterinarians and the horse ambulance. It was later reported that she had suffered an injury to her right hind leg and was transported to a clinic for evaluation.


