3<sup>rd</sup> RACE #6 "Yaba Daba Diva" (Miguel Mena) finished seventh, suffered a post-race heatstroke and required treatment from the KHRC veterinarians.

6<sup>th</sup> RACE CLEAR

7<sup>th</sup> RACE #2 "Gold Czar" (Jack Gilligan) finished ninth, suffered a post-race heatstroke and required treatment from the KHRC veterinarians.

8<sup>th</sup> RACE An objection was lodged by the rider of third place #5 "Gun It" (Joel Rosario) alleging interference by the rider of second place #3 "Bizzee Channel" (Florent Geroux) in deep stretch. After reviewing the race replay and interviewing the riders, the stewards determined that #5 came off the fence into the path of #3, causing his own trouble. There was no change in the order of finish and the race was posted official.

9<sup>th</sup> RACE CLEAR

10<sup>th</sup> RACE An objection was lodged by the rider of third place #8 "Sister Kitten" (Jose Ortiz) alleging interference by both the riders of second place #11 "Cambeliza" (James Graham) and the unofficial winner #2 "Blame Debbie" (Joel Rosario) in the stretch. After reviewing the race replay and interviewing the riders, the stewards determined that #2 angled in and caused the #11 to check into the #8 who was forced to take up sharply. Both the #11 and #8 lost momentum due to the interference. The objection against the #11 was disallowed. #2 was disqualified and placed behind both the #11 and #8.
