4th RACE #3 "City Magic" (Joel Rosario) was pulled up abruptly near the 1/2 mile pole and required the assistance of the KHRC veterinarians and the horse ambulance. After diagnostics were performed by the private veterinarian it was determined that the horse had suffered a catastrophic injury to his left foreleg and he was humanely euthanized. A claim that had been submitted for the horse was voided.

An objection was lodged by the rider of fourth place #11 "Holy Emperor" (Irad Ortiz, Jr.) alleging interference by the rider of third place #12 "Hard Knocking" (Rafael Bejarano) in the stretch. After reviewing the race replay and interviewing the riders, there was no interference and the race was posted official.

9th RACE #7 "Detroit City" (Adam Beschizza) flipped and unseated his rider in the starting gate. The colt eventually had turned completely around and was hung over the back doors of the stall. In releasing the horse from the tangle, he forcefully kicked the side of the stall and caused both his front door and the door of #6 "Pure Panic" (Joel Rosario) to open. #6 came out of the stall with the rider aboard and the assistant starter still holding on to him. Both #6 and #7 were examined by the KHRC veterinarian who recommended the scratch of both horses.
