**Description and Information about New and Amended  
Administrative Regulations Filed on March 15, 2022**

**The KHRC filed the following amended administrative regulations on March 15, 2022:**

**1. 810 KAR 3:020:**

- A. Summary of Administrative Regulation: This regulatory amendment is promulgated to amend the relevant application to include a "Military Spouse" option, as required by statute. Additionally, a "Stable Agent" license type is added, as well as additional edits to the application that will aid in providing the appropriate information.

**2. 810 KAR 4:010**

- A. Summary of Administrative Regulation: This amendment involves circumstances in which a horse is considered serviceable for racing and when the horse has a posted off date on or before the relevant race.

### **3. 810 KAR 4:030**
