Summary of Administrative Regulation: This new emergency administrative regulation will allow racing associations to offer pari-mutuel wagering on historical horse races while maintaining compliance with recent Supreme Court case law and the recently enacted Senate Bill 120. Also, this new emergency administrative regulation helps to consolidate the pari-mutuel and exotic pari-mutuel wagering definitions into one regulation rather than three, so that KAR Title 810 will be expanded to regulate pari-mutuel and exotic wagering on all types of live or historical horse racing.
