## **LICENSING Sports Wagering Frequently Asked Questions**

### **Q: How do I apply for a license?**

### **Q: If I'm an individual, what type of license should I apply for?**

Three types of licensure are available for individuals; Race and Sportsbook, Key Employee and Information Systems.

## **OCCUPATIONAL LICENSE: RACE AND SPORTSBOOK**

### **You need this license if:**

- You work in a licensed facility and your work is directly related to sports wagering.
- You directly supervise employees in any licensed Kentucky sports wagering business who have the capability of affecting the outcome of sports wagering.

- You are an employee in any licensed Kentucky sports wagering business and have the capability to affect the outcome of sports wagering through the deployment of code to production for any critical component of a sports wagering system.
- Your duties are performed in the licensed facility for sports wagering that involve money obtained as a result of sports wagering, such as the handling of tickets, money, or performing accounting and auditing functions.
- You are an operator or service provider whose duties: (1) are performed in a licensed facility for sports wagering and whose duties affect sports wagering; (2) affect the flow of money obtained as a direct result of sports wagering operations; and (3) include accounting and auditing functions and whose duties relate to money obtained as a result of sports wagering.

- IT professionals responsible for maintaining sports wagering technology infrastructure

- Security personnel
- Sports wagering facility management

### **You need this license if:**

You are working for sports wagering licensees and you are personnel with decision making authority.

## **OCCUPATIONAL LICENSE: INFORMATION SERVICES**

**You need this license if:**

You are working for sports wagering licensees in Kentucky who provide information services.

**Sports wagering employees who need to fill out this application include:**

1. Oddsmakers or traders
2. Data Source
3. Chief of surveillance
4. Support operations manager
5. Risk management
6. Player account management
7. Platform providers, such as geolocation technology, Know Your Customer, or sports wagering equipment providers

**Documents needed to complete the application:**

### **Can I request a waiver for licensure?**

An applicant may request a waiver from sports wagering licensure to prevent dual licensing for one individual across multiple disciplines. For example, if the applicant works at a facility that offers both horse racing and sports wagering, and the applicant holds a similar license with the Commission for horse racing, the applicant may seek a sports wagering licensure waiver to avoid duplicate licensing requirements.

To apply for the waiver, the individual must submit a waiver application. The Commission may grant or deny a waiver, upon consideration of at least the following factors:

- Nature of the applicant's duties
- The best interest and integrity of horse racing, pari-mutuel wagering, and sports wagering

An applicant may be denied a waiver if their job duties are directly related to sports wagering, or they supervise employees whose job duties are directly related to sports wagering.
