3rd RACE #14 "Bantu" arrived past the Lasix administration deadline and was permitted to race without the medication. The change was posted and announced prior to the opening of wagering.

6th RACE A Stewards Inquiry was posted when the rider of #7 "Kinenos" (Shaun Bridgmohan) was unseated shortly after the start. After reviewing the race replay and interviewing Bridgmohan the stewards determined that the winner #6 "Field Pass" (Tyler Gaffalione) took a step out into the vacant spot created when the #7 broke slowly, and #7 clipped the heels of #6, bobbled and unseated his rider. There was no change in the order of finish and the race was posted official. Both horse and rider escaped injury.

7th RACE The claim of #2 "Greater Cairo" was voided pursuant to 810 KAR 4:050 when the horse was placed on the KHRC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.
