Mr. Zyler Maxwell was the listed Driver of #6 Prince Palone who was in the 24 th Race during the Ballard County Fair at La Center Fairgrounds on $6/8/2025$ during the Kentucky Proud Series under the Jurisdiction of the KHRGC. Mr. Maxwell did use the whip excessively while out of contention violating 810 KAR 5:070 Section $9 - 3 - D - 7$. Mr. Maxwell did also drive the horse off the track in an unsafe and unprofessional manner. Mr. Maxwell received a warning prior to this action about some concerns which will increase this penalty as aggravating circumstances. The Board of Judges would like to note that Mr. Maxwell did admit and take full responsibility for his actions and the Board of Judges took this into consideration.
