Narrative

Ms. Alexandra Sarkine was the listed trainer of #4 Giggity Goo who was in the 1st race on 6/27/2025 during the Marion County Fair at Lebanon Fairgrounds. Post race testing of sample E621281 confirmed an overage of Dexamethasone of 7.62 pg/mL which is over the allowed 5 pg/mL which is a violation of 810 KAR 8:030. #4 Giggity Goo is hereby disqualified from 1st to UNPLACED and is ordered to return the purse of \$3,750 (Three Thousand Seven Hundred Fifty Dollars). Ms. Sarkine is assessed a penalty of \$1,000 (One Thousand Dollars) since this is her 1st violation of a Class C medication in 365 days.


