After waiving his right to a hearing before the Board of Stewards, Oscar Villarreal, who finished third aboard RYZEN in the ninth race at Turfway Park on January 1, 2025, was found to have violated HISA Rule 2280 (b)(2) by striking his mount seven times with the riding crop (2nd offense). Pursuant to HISA Rule 2282 (c)(1), Class 3, Oscar Villarreal is hereby fined five hundred dollars (\$500.00) and suspended two Kentucky racing days, Saturday, January 18 and Wednesday, January 22, 2025. Upon receipt of this ruling, it is required within thirty (30) days to pay any and all fines imposed to the Horseracing Integrity and Safety Authority.
