**After waiving his right to a hearing before the Board of Stewards, Corey J. Lanerie, who finished first aboard THEISMANN in the sixth race at Turfway Park on January 15, 2025, was found to have violated HISA Rule 2280 (b)(2) by striking his mount eight times with the riding crop. Pursuant to HISA Rule 2282 (a)(1), Class 3, Corey J. Lanerie is hereby fined five hundred dollars (\$500.00) and suspended one Kentucky racing day, Saturday, January 18, 2025. Upon receipt of this ruling, it is required within thirty (30) days to pay any and all fines imposed to the Horseracing Integrity and Safety Authority.**
