**Apprentice Jockey: Andres Calleja (HISA #P000010646)**

After waiving his right to a hearing before the Board of Stewards, Andres Calleja, who finished eleventh aboard MY LAST ESCAPADE in the eighth race at Turfway Park on January 16, 2025, was found to have violated HISA Rule 2280 (b)(2) by striking his mount seven times with the riding crop. Pursuant to HISA Rule 2282 (a)(1), Class 3, Andres Calleja is hereby fined two hundred fifty dollars (\$250.00) and suspended one Kentucky racing day, Saturday, January 25, 2025. Upon receipt of this ruling, it is required within thirty (30) days to pay any and all fines imposed to the Horseracing Integrity and Safety Authority.
