HISA **KENTUCKY STEWARDS RULING**

After a hearing before the Board of Stewards, Sophie Doyle, who finished fourth aboard SKYNET in the fourth race at Turfway Park on January 24, 2025, was found to have violated HISA Rule 2280 (b)(2) by striking her mount seven times with the riding crop (5th offense). Pursuant to HISA Rule 2283 (c)(1), Class 3, Sophie Doyle is hereby fined one thousand two hundred fifty dollars (\$1,250.00) and suspended five Kentucky racing days, February 5 through February 8 (inclusive) and February 12, 2025. Upon receipt of this ruling, it is required within thirty (30) days to pay any and all fines imposed to the Horseracing Integrity and Safety Authority.
