**HOMETOWN HERO finished seventh in the eighth race at Turfway Park on January 24, 2025. During the running of the race, jockey Jann Hernandez was found to have violated HISA Rule 2280 (b)(2) by striking his mount ten times with the riding crop. Owner Tito Moreno waived his right to a formal hearing before the Board of Stewards. Pursuant to HISA Rule 2282 (a)(2)(b), Class 2, HOMETOWN HERO is disqualified, and all purse money forfeited. Pari-mutuel wagering is not affected by this ruling. All purse monies must be returned to the association. The purse of this race is ordered redistributed as follows:**
