## HISA KENTUCKY STEWARDS RULING

After waiving his right to a hearing before the Board of Stewards, Angel Serpa, who finished fourth aboard OLD FASHIONED GIRL in the ninth race at Turfway Park on February 7, 2025, was found to have violated HISA Rule 2280 (b)(2) by striking his mount seven times with the riding crop (3<sup>rd</sup> offense). Pursuant to HISA Rule 2282 (c)(1), Class 3, Angel Serpa is hereby fined seven hundred fifty dollars (\$750.00) and suspended three Kentucky racing days, February 28, March 1, and March 5, 2025. Upon receipt of this ruling, it is required within thirty (30) days to pay any and all fines imposed to the Horseracing Integrity and Safety Authority.
